

UPHILL ADDENDUM

THIS AGREEMENT SUPPLEMENTS THE MASTER WAIVER AND RELEASE

UPHILL TRAVEL PASS AND CONDITIONS: Participants must purchase an Uphill Travel Pass or hold a valid lift ticket or season pass with an Uphill Travel endorsement. I understand that access to Bousquet Ski Area trails is undertaken entirely at my own risk. Uphill travel is permitted only from dawn to dusk and may be restricted or prohibited at any time.

ACKNOWLEDGMENT OF RISKS: I acknowledge that uphill travel is unpatrolled and involves numerous risks including, but not limited to, limited visibility, changing weather conditions, steep terrain, icy or unstable surfaces, and interaction with downhill traffic. I further acknowledge that closed trails and terrain parks may not be marked or signed from all access points, and that I may encounter snowmaking operations, snowmaking hoses, electrical lines, grooming equipment, winch cables, snowmobiles, and other machinery, all of which may be in operation at any time and may not be visible.

CONDUCT AND RESPONSIBILITY: I agree to stay to the side of trails, wear visible clothing, and choose a route that provides downhill traffic the best opportunity to see me. I understand that I may not be visible around sharp turns, knolls, or terrain features. I agree to follow designated uphill routes, which may change from time to time, and to check the snow report prior to leaving the base area to become informed of trail closures, snowmaking, events, or other operations.

I understand that once I reach the summit, downhill travel must occur only on open trails. If I am encountered by ski patrol during sweep, I agree to descend with ski patrol. I understand that dogs or animals are not permitted.

SUPPLEMENT: I agree that this Addendum supplements the Master Waiver and Release and that all terms, including assumption of risk, release of liability, covenant not to sue, and indemnification provisions, apply fully to uphill travel.

I HAVE HAD SUFFICIENT OPPORTUNITY TO READ THIS ENTIRE DOCUMENT. I HAVE READ AND UNDERSTOOD IT, AND I AGREE TO BE BOUND BY ITS TERMS. I FURTHER ASSERT I HAVE COMPLETE AUTHORITY TO EXECUTE THIS DOCUMENT FOR MYSELF AND ANYONE FOR WHOM I AM EXECUTING THIS DOCUMENT.
